  - c. A reference to a person includes firms, companies, government bodies, trusts and partnerships.
  - d. "including" also means "including without limitation".
  - e. Reference to any statutory provision includes any modification or amendment of it.
  - f. The headings and sub-headings do not form part of this privacy policy.

# Scope of This Privacy Policy

- 3. This privacy policy applies only to the actions of CES and Users with respect to this Website and Software. It does not extend to any Website that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, CES is the "Data Processor". This means that CES has created processes and systems then enable a Data Controller to gather and store personal data.

#### Data Collected

- 5. The following Data may be collected, which includes personal Data from You:
  - a. Name.
  - b. Date of birth.
  - c. Gender.
  - d. Contact information such as email address and phone numbers.
  - e. IP address.
  - f. Web browser type and version.
  - g. Operating system.
  - h. Information of children within the Software.
  - i. Financial data relating to bookings made.
  - j. Disability information.
  - k. Allergy Information.
  - I. Pupil premium status.
  - m. Language and Ethnicity information.

How We Collect Data



- 6. We collect Data in the following ways:
  - a. Data is given to Us by You.
  - b. Data is collected automatically.

# Data That is Given to Us by You

- 7. CES will collect Your Data in a number of ways:
  - a. When You contact Us through the Website, phone, post, email or other means.
  - b. When You register with Us and set up and account to receive Our products/services.
  - c. When You complete surveys that We use for research and development purposes (although You are not obliged to respond to them).
  - d. When You make payments to Us, through Our Website, Software or directly.
  - e. When You elect to receive marketing from Us.
  - f. When You use Our services.

# Data That is Collected Automatically

- 8. To the extent that You access the Website, We will collect Your Data automatically:
  - a. We automatically collect some information about Your visit. This Data helps Us to make improvements to content and navigation and includes Your IP Address, date, time, frequency, and the way in which You interact and use Our content.
  - b. We will collect Your Data automatically via cookies, in line with the cookies setting on Your browser.

# Our Use of Data

- 9. Any or all of the above Data may be required by Us from time to time in order to provide You with the best possible service and experience when using Our Website and Software. Specifically, data may be used by Us for the following reasons:
  - a. Internal record keeping
  - b. Improvements to our services and products
  - c. Transmission by email of marketing materials
  - d. Contact for market research purposes
- 10.We may use Your Data for the above reasons if We deem it necessary to do so for Our legitimate interests. If You are not satisfied with this, You have the right to object in certain circumstances.
- 11.For the delivery of direct marketing to You, we'll need Your consent, whether via an opt-in or soft-opt-in;



- a. soft opt-in consent is a specific type of consent which applies when You have previously engaged with Us (for example, You contact Us to ask Us for more details about a particular product/service, and We are marketing similar products/services). Under "soft opt-in" consent, We will take Your consent as given unless You opt-out.
- b. for other types of e-marketing, We are required to obtain Your explicit consent; that is, You need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.
- c. if You are not satisfied about Our approach to marketing, You have the right to withdraw consent at any time. To find out how to withdraw Your consent, see the section headed "Your rights" below.
- 12. When You register with Us and set up an account to receive Our services, the legal basis for this processing is the performance of a contract between You and Us and/or taking steps, at Your request, to enter into such a contract.
- 13.We may use Your Data to show you CES adverts and other content on other websites. If You do not want Us to use Your data to show You adverts and other content on other websites, please turn off the relevant cookies.

#### Who We Share Data With

- 14.We may share Your Data with the following groups of people for the following reason:
  - a. Any of Our group companies or affiliates
    - i. To ensure the proper running of Our website and business.
    - ii. To ensure effective support can be provided between end users, customers and Us
  - b. Our employees agents and/or professional advisors
    - i. To help improve the system as a whole and relevant training requirements
    - ii. To obtain any advice from professional advisers
  - c. Third party service providers who provide services to Us which require the processing of personal data
    - i. To help third party service providers in receipt of any shared data to perform functions on Our behalf to help ensure the website and software runs smoothly.
    - ii. To help with development of Our services
  - d. Third party payment providers who process payments made over Our Website or Software
    - i. To enable third party payment providers to process user payments and refunds
  - e. Relevant authorities
    - i. To facilitate the detection of crime or the collection of taxes or duties



# **Keeping Data Secure**

- 15.We will use technical and organisational measures to safeguard Your Data for example;
  - a. Access to Your account is controlled by a password and a user name that is unique to You.
  - b. We store Your Data on secure servers.
- 16.Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to Your Data, please let Us know immediately via:

#### Data Retention

- 18.Unless a longer retention period is required or permitted by law, We will only hold Your Data on Our systems for the period necessary to fulfil the purposes outlined in this policy or until You request that the Data be deleted.
- 19. Even if We delete Your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

#### Your Rights

- 20.You have the following rights;
  - a. **Right to Access** the right to request;
    - i. Copies of the information We hold about You at any time
    - ii. That We modify, update or delete such information.

If we provide You with access to the information We hold about You, We will not charge You for this unless Your request is unfounded or excessive. Where We are legally permitted to do so, We may refuse any request. If We refuse Your request You will be given the reasons why.

- b. **Right to Correct** the right to have Your Data rectified if it is inaccurate or incomplete.
- c. **Right to Erase** the right to request Your Data is removed or deleted from Our system.
- d. **Right to Restrict the use of Your Data** Right to block Us from using Your Data or limit how it can be used.
- e. **Right to Data Portability** Right to request that We move, copy or transfer Your Data



- f. **Right to Object** Right to object to Our use of Your Data including where We use it for Our legitimate interests.

- 22.If You are not satisfied with the way a complaint You make in relation to Your Data is handled, You may be able to refer Your complain to the relevant data protection authority. For the UK this is the Information Commissioners Office – ice.org.uk
- 23.It is important that the Data we hold about You is accurate and current, please keep us informed of any changes to Your Data.

### Transfers Outside the UK and EEA

- 24.Data which we collect from You may be stored and processed in and transferred to countries outside the UK and EEA. This could occur if our servers are located in a third party country or our service providers are outside the UK/EEA.
- 25.We will only transfer Data outside of the UK and EEA where it is compliant with data protection legislation and the means of transfer provides adequate safeguards in relation to Your Data.
- 26.To ensure that Your Data receives an adequate level of protection, We have put in place appropriate safeguards and procedures with the third party companies we share Your Data with. This ensures that Your Data is treated by those third parties in a way that is consistent with the Data Protection Laws.
